## Public pools and spas must comply with new law or face major fines

With less than a week before the deadline to comply with a new federal pool safety law, pool contractors are stepping up their efforts to retrofit suction drains across the valley with anti-entrapment covers. Public pools and spas, including those in the area's country clubs and resorts that do not meet compliance by December 19, 2008 face up to \$1.8 million dollars in fines and criminal penalties.

"Proper drain covers and easily accessible cut-off switches that can prevent an entrapment in a pool or spa are critically important, said Nancy Nord, commissioner of the Consumer Product Safety Commission (CPSC) after President Bush signed the Virginia Graeme Baker Pool and Safety Act last December. "Drowning is one of the greatest dangers to children in and around the home, and we share a commitment with state and local government agencies, consumer safety groups and industry to improve pool and spa safety."

The Virginia Graeme Baker Pool and Safety Act is named after the seven-year-old granddaughter of former Secretary of State James Baker who drowned after drain suction in a hot tub did not allow her to swim back to the surface. According to documents that supported the bill, there have been 147 incidents documented of suction entrapment in U.S. swimming pools, including 36 deaths, since 1980.

From the day the deadline was announced, pool and spa contractors at Teserra have been installing the anti-entrapment drain covers, which look something like an octopus, throughout the Valley and beyond. Only licensed pool contractors are allowed by law to install the regulated drain covers that are then

subject to approval by the Riverside County Health Department. For all new construction, the CPSC recommends gutters, overflows and/or skimmers to provide water circulation.

"Now that the hazards of these older drains are better understood, it is imperative that we upgrade all pools and spas with these new drain covers," said James Harebottle, Teserra President and CEO. "We create backyard environments that are fun and inviting, and we want people to feel comfortable with their safety too."

Harebottle said Teserra's team is also helping customers meet other requirements of the law when constructing a new pool or spa. Some of these include installation of an automatic shut-off system, gravity drainage system, safety vacuum release system or suction-limiting vent system or disabling the drain if the pool operates off of a single, main drain.

Jeanette Sweet, of Sweet Swim School provides lessons for all ages in the spring and summer. After seeing a demonstration of a man trying to lift a 50-pound bag of sand off a suction drain, she said she became very concerned. She checked all the pools where she was instructing for these types of drains and told every parent she could about the danger and the new law.

"Knowing what kind of drain the pool has where you are swimming is important, but there are many other reasons kids drown," said Sweet, who has been teaching swimming for 23 years. "We must do everything we know to do to keep our kids safe. Changing out drains is one thing, but never taking your eyes off a child near a pool is something we must continue to do even after these drains are updated." **TPR**
